Meet Data Download Template – We are working to create a template for coaches to download consistent athlete info from the USAG membership site for meet entries. Any errors must be corrected on

the USAG site by coaches as soon as they become apparent. Meet directors should be able to download identical info without discrepancies directly into *ProScore*. The objective is to have a single source of accurate athlete info at USAG membership that both coaches and meet directors access for meet entries.
