**Qualification to Compulsory State Meet** – must be achieved at an in-state, scheduled, seasonal meet adhering to Wisconsin guidelines (including established entry fees) **OR** through petition to the State Board with scores from a non-compliant meet.

**Level 8-10 Specialists with a 9.0 may qualify to State Meet on that event.** – Declaration as a Specialist must be made on the State Meet entry form. They will count toward team score but will receive (separate) duplicate awards thereby not displacing All Arounders for event awards.

## Agenda Issues Voted on at 3/27/10 Board Meeting:

**Age Groups must be split to a Maximum of 35 Gymnasts** (decreased from 45) with 50% awards given up to 15 places.

**Level 8-10 Specialists may petition to State Meet** using USAG R&P procedures.

**Participation Awards** – must be given at all Compulsory Level State Meets.

## Agenda Issues Voted on at 2/17/10 Board Meeting:

**PREP Optional Season** – will be conducted in the winter/spring during the Optional season but with PREP Op State Meet held in May (not Mother’s Day or Memorial weekend).

**PREP Optional Qualification to State Meet** – Participation in 2 in-state PREP Op meets or through petition to State Board.

**Wisconsin PREP Optional Rules & Policies** – is based on Region 5 PREP Optional guidelines using the Bronze, Silver and Gold divisions only.

**Level 3 “2<sup>nd</sup> Season” State Meet** – will be conducted in May and may be held in conjunction with PREP Optional State Meet. Qualification is through participation in 2 in-state seasonal meets or by petition to the State Board.

**Submit Optional seasonal meet dates and bids for State Meet to State Chairman by June 15 deadline.**
